Rules of Play – “Won” Vancouver

- All VCH Staff are eligible to play.
- Max 5,000 tickets sold per lottery.
- Participants must be 19 years of age or older. If the winning ticket bears a minor’s name, the prize will be lawfully delivered on behalf of the minor to the minor’s parent, legal guardian or trustee.
- This is a bi-weekly payroll deduction raffle with one winning ticket drawn and one winner receiving 50% of the total money for that draw.
- Tickets may be sold and purchased only in British Columbia.
- Draw dates and locations are on the last Friday of each month beginning November 2015 and ending in October 2016 at 2:30 pm in the administrative area level 1 Centennial Pavilion, 855 West 12th Avenue, Vancouver, BC
- Each pay period VCH payroll staff will provide a list of all payroll deduction participants. Only these participants will be eligible for that draw. Individuals not working in the pay period will not be eligible to play.
- Once your application is received by VCH, a notification will be sent via email. Because of cut-off dates for VCH pay periods, it may take two-three weeks before payroll deductions begin.
- Participants will be entered for eligible draws through the period of November 2015 through October 2016.
